

## SECTION V – PROHIBITED ACTS

The regulations set forth below governing the use of the park, playground and ball field within the Borough of Portersville are hereby adopted.

- A. No person shall sell, use, possess or transport any drugs, paraphernalia, alcoholic beverage and/or intoxicating liquor within the limits of the park, playground or ball field.
- B. No person shall gamble in any form.
- C. No person shall wash, clean, polish or repair any vehicle or any other article or item of personal property.
- D. No person shall ignite, kindle or drop any fire of any kind at any time except where authorized by the Portersville Borough Council.
- E. No person shall park or operate any motorized vehicle of any kind, including but not limited to a car, truck, bus, motorcycle, mini-bike, or all-terrain vehicle, except where authorized by Portersville Borough Council, which is the gravel roadway and parking lot.
- F. No person shall indulge in any threatening, abusive, insulting or indecent language, commit any obscene, indecent or disorderly act, or commit any public nuisance.
- G. No person shall ride, lead or graze any horse or pony except by permission. No person shall allow any domestic animal for which he/she is the owner or possessor to be at large at any time.
- H. No person shall disturb, annoy, strike, injure or kill any animal or bird.
- I. No person shall cut, break, injure, mutilate remove or deface the trees, shrubs, plants, pond, buildings, structures, signs, picnic tables, restroom facilities or any other park, playground, or ball field property, including sand, stones, clays or minerals.
- J. No person shall discharge any firearms, knives, air guns, bb guns, slingshots or any other type of weapon.
- K. No person shall erect, maintain, or distribute any signs, advertisements, circulars or other printed matter without permission from Portersville Borough Council.
- L. No person shall collect or solicit any funds or distribute any literature without written permission from Portersville Borough Council.
- M. No person shall sell or offer for sale any articles of any kind or any food without written permission from Portersville Borough Council.
- N. No person shall participate in group activities other than normal park activities.
- O. No person shall swim or wade in the park pond.
- P. No camping, hunting, or trapping is allowed without written permission from Portersville Borough Council.
- Q. No person shall bring or deposit trash, refuse, earth, building materials or similar materials into the park, playground or ball field.
- R. No person shall deposit any refuse incidental to the property and authorized use of the park, playground, and ball field except in containers provided for that purpose.
- S. No person shall golf at any time.
- T. No person shall expose themselves, excrete or urinate at any time in the park, ball field or playground.
- U. No person shall conduct or participate in any group activity, except in designated areas and without first obtaining a permit from the Council member who is chairman of the park committee or the Borough Secretary, at a fee to be determined by the Portersville Borough Council.
- V. No person shall use the park, playground or ball field before 10:00 a.m. or after 10:00 p.m.
- W. The Portersville Borough Council may, by resolution, adopt additional regulations governing the use of the park, playground, and ball field and impose such fees therefore as they deem appropriate.

## SECTION VI- VIOLATIONS AND PENALTIES

Whoever violates any regulations set forth in this ordinance or any provision of any rule or regulation adopted by the Portersville Borough Council, pursuant to the authority granted by law, shall be fined not more than \$200.00 and costs
